Each participant must fill out their registration form individually, as group registrations are not possible. Registrations will be processed on a “first come – first served” basis.

Registration types and fees

Registration deadlines are shown in Finland’s time zone (EET).

Early Bird fee, until 20.3.2025	135 EUR
Regular registration fee, from 21.3.2025 until 22.4.2025	200 EUR

The following registration types will require a code to complete the registration: programme committee and local organising committee members.

Additional programme: Evening reception and excursions*Evening reception at Arktikum Science Center*

The evening reception on Wednesday 14 May is included in the registration fee. Registration is required for catering and practical purposes.

Excursions

Each participant is entitled to participate in one excursion, included in the registration fee. The excursions will take place on the afternoon of Thursday 15 May.

Three excursion options are available. Please note that places are limited and will be allocated on “first come – first served” basis.

- Guided adaptation walking tour in Rovaniemi

Credit card and invoice payments

You can pay by credit card (Visa, MasterCard, Google Pay) or via bank transfer with an invoice.

- Online credit card payment:
 - Accepted payment options: Visa, MasterCard and Google Pay
 - Prepaid credit cards are not accepted
 - Online credit card payments are processed through a secure payment page at the end of the online registration form.
 - Registration and other reservations will be confirmed only after full payment has been received.
- Invoice payment:
 - An invoicing fee EUR 19 will be added to all invoices. Please note that an additional fee of EUR 19 will be charged for any changes to a sent invoice (e.g. invalid invoicing address or additional data not given during registration).
 - The invoice reference number must be used as identification for bank transactions. The invoice will include all necessary international bank information for the bank transfer. The payer is responsible for covering all bank charges.
 - Registration and other reservations will be confirmed only after a full payment has been received.
 - Sending e-invoices to organisations outside Finland is not currently possible. Only Finnish participants can request an e-invoice (verkkolasku).

Cancellation policy and insurance

All cancellations must be submitted in writing to nocca2025@confedent.fi.

- For cancellations made by or on 14 April 2025, a full refund will be issued minus a handling fee of EUR 50
- For cancellations made after 14 April 2025, no refunds will be made.

Please note that if you cancel your participation after 14 April 2025, you will be required to cover the full fee, even if you have not paid it before the cancellation. No-show is not considered a cancellation. Denial of a visa application to Finland does not entitle a participant to any refunds.

The registration fee does not include any form of insurance. Please ensure the validity and coverage of your own travel insurance. The conference organisers cannot accept liability for personal injuries sustained, for loss of, or damage to property belonging to participants (or their accompanying persons), either during or as a result of the conference.

The organisers do not take responsibility for cancellations due to force majeure (natural hazards, outbreaks of severe contagious epidemics, major strikes, etc.). In such cases, the organising committee reserves the right to decide on the refunding of paid registration fees.
